

IMPRESSIVE POMERANIAN'S SALES CONTRACT & HEALTH GUARANTEE

This agreement is made by and between Cherilyn Simagna hereinafter referred to as "Breeder" and _____ hereinafter referred to as "Buyer" for the purchase of the below named Pomeranian.

Buyer has purchased a (sex) _____ (color) _____ Pomeranian called _____ hereinafter referred to as the "Puppy" for the purchase price of \$ _____ with

We try our best and sell only healthy happy puppies. The Puppy will be current on vaccinations and worming prior to their departure. We disclose any of their health issues to you prior to their sale. All of our puppies will have been recently examined by a licensed veterinarian and will have received a clean bill of health certificate prior to their shipment. Because of this thorough veterinary examination Breeder gives the Buyer a 72 hour health guarantee against life threatening illness. Buyer is responsible make an appointment prior to the Puppy's arrival home with a licensed Veterinarian to have said Puppy examined (at Buyers cost) within 72 hours of Puppy's arrival for the guarantee to be valid. If the Puppy is found to have a life threatening illness that will cause death or if the Puppy dies within the 72 hour guarantee time, the buyer must notify Breeder at once with the following information: Date Puppy was examined; Name, address and phone number of the licensed Veterinarian who examined the Puppy; The diagnosis and all medical records; Autopsy if needed. Additionally a signed statement from Buyer releasing Puppy's medical records to Seller must also be included. After all necessary information has been received by Seller, Seller may have their veterinarian review diagnosis prior to the return of the Puppy. Buyer is responsible to make the arrangements to ship Puppy back to the breeder (at Buyers cost) within 72 hours from the date of diagnosis with the requested information and all registration paperwork. Breeder will take the Puppy to their Veterinarian and if the same life threatening illness is confirmed or if death has occurred as a result of a life threatening illness, Breeder will replace the Puppy with one of the same value when one becomes available for up to eighteen months from the date of sale. The replacement puppy may be from a different litter at a latter date or from different parents. Replacement is the only option, we do not give cash refunds PLEASE NOTE If Buyer decides to have the Puppy treated for illness instead of returning Puppy, Breeder will not be held responsible for any veterinary bills or replacement puppy and this guarantee becomes VOID. Additionally if the said puppy is deemed to ill to be safely shipped back to us Breeder may at our discretion choose to pay to have the puppy treated locally for the said illness. However we will only reimburse up to the purchase price of the puppy only. Shipping is always the responsibility of the Buyer.

Also remember DO NOT let your new puppy around strangers or unvaccinated dogs, shoes, veterinary floors, grass areas or anywhere that other dogs have been until after all puppy vaccinations are completed. Your new puppy is not fully protected from life threatening illness until ALL vaccinations and boosters are complete. Because we cannot control the environmental exposure where your puppy is located after it leaves our care we cannot guarantee against its exposure and/or contraction of puppy diseases such as Kennel cough, parvo & distemper. Remember, your puppy was healthy when it left our care, therefore if your puppy is diagnosed with a life threatening illness after our 72 hour health guarantee it is your responsibility as a pet owner to care for your pet. Because of the nature of a live animal and our inability to control the feeding and care of your Puppy after it has left our care we cannot make any further guarantee's.

All our Puppies are sold as companion pets only. We only want permanent loving pet homes for our Puppies! It is up to the Buyer to decide whether or not to use the Puppy for breeding purposes. Because of the age at which puppies leave our care and the nature of a live animals subject to environmental influences we cannot Guarantee the color, size, breeding or show quality or temperament of the Puppy.

Nor can we guarantee against, hypoglycemia (low blood sugar), broken bones, luxating patellas or small open fontanel (common in toy breeds), un-descended testicles, bite, parasites or any condition that is treatable and not life threatening. If Buyer changes their mind for any reason about the purchase of the Puppy or is no longer able to care for the Puppy at any time, Buyer will not receive a replacement puppy or a refund. However, please contact us and we will try and help you locate a suitable new home for your Puppy.

Please do not put your puppy on high places including furniture where it may fall and injure itself. Watch small children who may handle your puppy, although children love puppies Pomeranians are very small and could be seriously injured or killed if dropped or over-handled. MAKE SURE your puppy is eating and drinking regularly! Treat your small puppy just as you would an infant child.

Additionally please read and understand the important information page on our website www.impressivpom.com/important.html with valuable information on preventing and treating hypoglycemia which is very common in toy breed dogs. You need to have a tube of Nutra-Cal supplement on hand to prevent hypoglycemia in your new puppy, especially if your puppy is estimated to mature under 6 pounds. You can purchase this from your Veterinarian or Pet Store.
